

Background Note

India and Belgium are two global players in the fields of life sciences, vaccines and pharmaceuticals / therapeutics and should therefore be strategic partners in the fight against the Covid-19 pandemic.

India, often called "the world's pharmacist", produces 60% of the world's vaccines and accounts for 60-80% of the UN's annual vaccine procurement. India's medical research institutes and pharmaceutical manufacturing companies have been rapidly expanding their already voluminous production capacities and are accelerating the development of vaccines in response to the Covid-19 outbreak. At least 7 Indian pharmaceutical companies are working to develop a vaccine against Covid-19. Prime Minister Narendra Modi's most recent speech for the UN General Assembly was largely devoted to the role of India as a global supplier of Covid-19 vaccines.

Belgium is a leading player for pharmaceuticals, therapeutics and vaccines, counting over 200 innovative pharma businesses including world renowned companies such as UCB, Janssen Pharmaceutica, GSK, Pfizer and Baxter. It is the EU's second largest pharmaceuticals exporter and stands second in the EU in terms of clinical trials per inhabitant. Belgium is also a world-class player in terms of life sciences and R&D, with an internationally competitive research infrastructure driven by its universities and major research facilities. According to the latest World Bank figures, Belgium ranks 10th worldwide in terms of GDP spending on R&D. As a result, Belgium plays a global leading role at every stage of the development of Covid-19 vaccines and therapeutics.

Belgium is also centrally located in the European continent and connected to Europe and the world thanks to a highly developed logistics infrastructure of airports, roads, railways and ports. Liege Airport was recently voted as best cargo hub in the world and has been selected by the World Health Organization (WHO) as one of 8 hubs worldwide for the distribution of Covid-19 medical supplies. Brussels Airport is the first airport ever to receive the "IATA Excellence in Pharmaceutical Handling" certificate and has 30.000 square meters of temperature controlled pharmaceutical warehouses – the most of any European airport.

The aim of this high-level online seminar, with top speakers from both countries' pharma, vaccines, life sciences and logistics industries, is to explore further possible cooperation between India and Belgium in two major fields in which Belgium is a global champion, and this through two main roundtable panels.

A first panel will focus on the role of Belgium as a hub in Europe and the world in the field of innovative vaccines, therapeutics and life-sciences. The main aims of this roundtable are to provide more insights on the strengths and opportunities of the general Belgian biotech ecosystem, the agility of the existing Belgian R&D biotech eco-system that has led to a quick reply in COVID-19 research, promising COVID-19 vaccines that are made in Belgium, other therapeutic areas beyond COVID-19 in which Belgium plays a key role such as cell & gene therapy, and the ambitions of the new Belgian government in terms of the further development of a health and biotech valley.

A second panel will look into the different ways Covid-19 vaccines and therapeutics will find their way from their inception via a safe and efficient global distribution to their end-users. The global distribution of effective Covid-19 vaccines is going to be one of the greatest logistical challenges we have ever faced. In 2021 the world will have to rely on a robust and bullet-proof supply chain integration alongside a solid and reliable air cargo capacity. This will require highly specialized approaches towards transportation, large cold storage facilities and experienced professionals. The seminar will provide exclusive insights in the Belgian expertise in this field – including by representatives of the airports of Liege and Brussels.
